- Slavery, servitude and forced or compulsive labour.
- Human trafficking

We have a responsibility to ensure that workers are not being exploited, that they are safe and that relevant employment, health and safety, human rights laws and international standards are adhered to, including freedom of movement and communications. We are committed to improving our practices to combat slavery and human trafficking.

Our Supply Chain

We are committed to ensuring that there is no modern slavery or human trafficking in our supply chain or in any part of our business. Our Ethical Business Statement reflects our commitment to acting ethically and with integrity in all our business relationships and to ensure fair conditions and treatment for all.

Fomac procures products and services to maintain the integrity of the business, key areas being:

Identification of potential risk of slavery and human trafficking areas in the business

Fomac has identified the following business areas as having the most significant potential risk:

- The provision of Agency labour
- The Supply Chain

The provision of agency labour

The potential risk – enslaved or human trafficked individuals are placed in work as agency labour with clients.

Risk control – rigorous checks are made on every individual including eligibility to work, references, qualifications, proof of NI, and bank details to ensure each person is acting in their own right.

The Supply Chain

The potential risk – the use of suppliers that contravene the Modern Slavery Act 2015

Risk control – new and current suppliers at evaluation and re-evaluation are verified as being in compliance with the Modern Slavery Act 2015

Due diligence process for slavery and human trafficking

As part of our initiative to identify and mitigate risk;

- We conduct internal audits on our Candidate Registration, Selection and Placement procedures to ensure that only eligible workers are placed with our clients.
- We evaluate new key suppliers and verify via their Modern Slavery & Anti Trafficking Policy their compliance to the Modern Slavery Act 2015.
- We evaluate all current key suppliers annually and verify via their Modern Slavery & Anti Trafficking Policy their compliance to the Modern Slavery Act 2015.
- Our suppliers are locally based where we can influence our commitment.
- National or international supply chains, with our point of contact often with a UK company are expected to have suitable policies in place. It is not practical to have a direct relationship and influence with all levels of our supply chain.

Monitoring Effectiveness

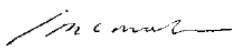
We measure the effectiveness of our risk control measures and due diligence to ensure that slavery and human trafficking is not taking place in our business or supply chains. The Key Performance Indicators (KPIs) are;

100% pass rate in the internal audits of the Candidate Registration, Selection and Placement procedures

100% confirmation of key suppliers being in compliance with the Modern Slavery Act 2015
